



PUBLIC NOTICE 02.26.18

2018 Submersed Aquatic Vegetation Control Program



The Division of Boating and Waterways will be conducting herbicide treatments in parts of the Sacramento-San Joaquin Delta region to control ***Egeria densa*, curly-leaf pondweed, Eurasian watermilfoil, fanwort and coontail.**

The following information is subject to change based on governmental requirements, weather conditions, plant growth, waterway traffic, special status species surveys, presence of sensitive crops in adjacent lands, and other conditions.

Proposed Herbicide Treatment Period

March 12, 2018 – Nov 30, 2018. Treatment period is based upon DBW field survey data, water temperatures and other conditions.

Potential Treatment Areas*

In and/or around the following areas:

- **Anchorage, Boat Ramps and Marinas:** B & W Resort, Big Break Marina, Das Cliff House, Delta Marina Rio Vista, Delta Yacht Club, Driftwood Marina, Grindstone Joe's, Hidden Harbor Resort, Hogback, Korth's Pirates Lair, Lloyd's Holiday Harbor, Long Island Slough, New Bridge Marina, Owl Harbor, Oxbow Marina, Perry's Boat Harbor, Rivers End, St. Francis Yacht Club, Tower Park, Willow Berm and Snug Harbor.
- **Near Old River:** Cruiser Haven, Diablo Ski Club, Discovery Bay, Franks Tract, Piper Slough, Sandmound Slough and Taylor Slough.
- **Sacramento Area:** Barker Slough, French Island, Lindsey Slough and The Meadows.
- **Stockton Area:** Atherton Cove, Bishop Cut, Buckley Cove, Disappointment Slough, Duraflame, Fourteen Mile Slough, Honker Cut, Mosher Slough, Pixley Slough, White Slough and Windmill Cove.

*Individual areas will be noticed prior to treatment application. If all listed sites can be treated, acreage will total 4,256 acres. See [map](#) for treatment areas.

Herbicides Being Applied

Fluridone. Herbicide is registered for aquatic use with US Environmental Protection Agency and the California Department of Pesticide Regulation.

Precautions

The public should not gather on or near boat docks during treatment applications. Boaters, swimmers, fisherman and other recreationists in an area being immediately treated are urged to heed directives by herbicide technicians, as they are aimed at protecting public safety.

Monitoring

Treated areas will be monitored weekly to ensure herbicide levels do not exceed allowable limits, or have any significant adverse impacts on the environment, agriculture, or public health in or near the above mentioned treatment areas.
