<p><b>DOES NOT REQUIRE</b> the items listed in the Tier 2 column</p>	<p><b>DOES REQUIRE GRANTEE TO:</b></p> <ul style="list-style-type: none"> <li>• Submit a CDFW-approved Prevention Plan and letter (with application).</li> <li>• Post DBW signage at the Project site.</li> <li>• Develop a survey plan and transmit surveys for public outreach</li> <li>• Participate in at least 3 community outreach events</li> <li>• Data from ramp monitor contacts, if that is a Project that was funded</li> </ul>
<p><b>Both Tier 1 and Tier 2 Projects require the Grantee to complete:</b></p> <ul style="list-style-type: none"> <li>• Quarterly, Annual, and Final Project Reports<sup>2</sup></li> <li>• Early-detection mussel monitoring data (EDMM data) <ul style="list-style-type: none"> <li>○ Required twice during the grant term to demonstrate that reservoir remains uninfested</li> </ul> </li> <li>• Project Deliverables</li> <li>• Final Inspection/Certification Form(s)</li> </ul>	
<p><b>Tier 1 Reports</b> are required to address:</p> <p><b>Quarterly</b></p> <ul style="list-style-type: none"> <li>• Work performed, accomplishments, milestones achieved, outreach, problems with performance, monitoring results</li> </ul> <p><b>Annual</b></p> <ul style="list-style-type: none"> <li>• Conditions plan will alleviate</li> <li>• EDMM Data</li> <li>• Progress summary, milestones achieved</li> <li>• Photos as appropriate</li> </ul>	<p><b>Tier 2 Reports</b> are required to address, in addition to the points listed in the Tier 1 column:</p> <p><b>Annual</b></p> <ul style="list-style-type: none"> <li>• Evaluation of effectiveness of the Project</li> <li>• Ramp monitor contact data, if funding inspection/decontamination activities</li> <li>• Photo proof of DBW signage at the site</li> </ul> <p><b>Final</b></p> <ul style="list-style-type: none"> <li>• Mussel preventative measures implemented in the reservoir</li> </ul>
